



PURCHASING AND SHIPPING INFORMATION

1. You must be 18 years of age or older in order to purchase fireworks.
2. **Minimum Mail Order Purchase is \$200.00** (Sorry, NO Exceptions)
There is also a **\$15.00** packing and handling charge on orders.
3. **IMPORTANT:** The sale of our merchandise is based solely upon the representation by you (the customer), that it will be used strictly in accordance with the law and the regulations applicable at the point of destination. **Fireworks Productions, Inc.** will not assume liability for any injury during use, handling, storage, or sale of this merchandise.
4. Prices in this catalog supersede all previous price lists. Prices may be subject to change without notice.
5. **Payment Information for Mail Orders:** You may pay by Money Order, Cashier's or Certified Check (**No Personal Checks will be accepted**) in order to speed up your order processing and shipment. In addition, we also accept the following credit cards:

(Please add 4.5% to the order total when using a credit card)
6. **COMMON CARRIER SHIPPING INFORMATION:** Shipment will be made by Commercial Truck (Common Carrier). Your Ship to location must be able to accept freight shipments. We strongly advise you to arrange for delivery to a work or business address. This will reduce both delivery time and shipping complications.

All shipments to residential addresses will be delivered to the closest trucking terminal to that location. The trucking company will notify you to arrange for you to pick up your order.
7. **FREIGHT CHARGES:** All freight charges must be prepaid. Freight charges start at \$80.00 and should be calculated at the rate of approximately \$10.00 per each \$50.00 of merchandise.

8. Fireworks Laws vary widely from state to state. Please visit the website address listed below to verify the types of fireworks that can legally be shipped to and used in your state.

Fireworks cannot be shipped via UPS or the US Postal Service.

9. **REFUSED – RETURNED FREIGHT** – If your shipment is refused, you will be charged for the return freight cost and a restocking fee of **15 percent** of the merchandise total.

10. **LOST, STOLEN OR DAMAGED SHIPMENTS** – Please inspect your order upon arrival. Remember to compare the number of boxes received to the number of boxes referenced on the Bill of Lading and your Packing List.

Lost, stolen or damaged package claims must be made with the Commercial Freight Company. They will reimburse you for any damaged or missing merchandise. Be sure to obtain a signature from the delivery driver acknowledging the damaged or missing merchandise.
Fireworks Productions, Inc. will not be responsible for any confiscations.

11. Please fill out and sign the enclosed order form. Orders received without the required signatures for **HOLD HARMLESS** and **LEGAL COMPLIANCE STATEMENTS** will be delayed until the signatures are received.
